1. Roanoke Fire Department: October is Fire Prevention Month

Rebecca (Becky) Smith, Battalion Chief

Call response time is 3 minutes. Safety Tips: Smoke alarms are first line of safety defense. Sleep with bedroom doors closed. Close doors behind you as you leave a burning building. Smother

grease fires with a lid. Currently a program where fire department will replace any smoke detectors over 10 years old. Call: 540-853.2795. Recent house fire on Abelmarle Ave. in OSW with a fatality (property owner). OSW concern: house is not demolished (Code Enforcement).

2. Roanoke Tree Stewards (non-profit arm is called Trees Roanoke)

Henry VanGilder & Don Mugford (education coordinator/lives in OSW). Established 2009. They are volunteers in the "urban forest." Plant ~100 trees per year. Trained 140-150 volunteers but only only ~20 are active through Roanoke Parks & Rec. Trainings are free: 9 Monday nights, 6-8pm & 3 volunteer Saturdays planting and pruning. Only work on public property. Roanoke loses ~250 trees per year. City has no budget for replacement. This groups serves that purpose.

OSW Safety Discussion

Online Safety Map was shared. Crime was light in OSW this month. Our OSW Safety officer, Julie Gale, met with the Highland Park Elementary School safety officer about traffic issues near the school. Tickets will be issued for speeding, cell-phone use, rolling through stop signs. Need crosswalks painted on road. They will present at a future OSW meeting.

Neighbor safety requests: Have the City paint crosswalk markers on Fifth and Mountain (at Sunnyside Market). Many people cross there, and someone in a wheelchair was hit. Request for no trucks signs posted on Mountain Ave—very narrow/tree limbs are being torn down.

Dog bite issue reported by a neighbor at an illegal Airbnb on Day Ave 300 block. Offending dogs were unleashed. Owners were uncooperative & tried to dodge identification. They have been identified & dealt with. TIP: If you are bitten, find out dog vaccine status. Call police AND animal control. Dog quarantine is required. Roanoke has a leash law.

Some drug dealing and use noted in front of Sunnyside Market. (Store owners actively monitor this.) No follow-up yet on Southwest Market issues discussed at previous OSW meetings.
