6:00-6:30 Social

David Jeavons (Treasurer) Chaired the evening.

6:30-7:30 Speakers

Focus on long-standing safety & nuisance issues in OSW—particularly in the area of Fifth St/Elm Avenue/Mountain (area of Southwest Market). NOTE: OSW, Inc. supports neighbors with issues like this by bringing the right resource people together to hear complaints and offer ideas to help abutters take action.

Existing issues include:

Loitering, littering, consumption of alcohol on the property, drunkenness, possible drug use/dealing, profane language, taunting passers-by, fights, defecating and urinating in the alleyway, disruption of other businesses and abutting properties, theft/porch thefts, derelict houses, homelessness/squatting on vacant properties.

Action to date: Abutters have logged 72 calls to law enforcement. A business owner/abutter has offered to purchase the Southwest Market property to clean it up or remove it entirely. ABC was made aware that the liquor license at Sunnyside Market was revoked at some time in the past for many of the same complaints. He is going to research this and address it in relation to Southwest Market. These problems were raised at OSW meetings several months ago. This resulted in the development of a safety brochure distributed in the neighborhood.

Action items/suggestions based on conversations at the meeting:

ABC can look into liquor license violations. Neighbors need to carefully document occurrences—dates, times, etc. Notify police, ABC rep, code enforcement -- depending on the issues observed. ABC rep intends to talk to the owner of the Southwest Market Business.

Housed 85 people since January 2022 and reduced homelessness by 60% since 2012 Increase in substance use and untreated mental health issues has increased homeless visibility (not in shelters)

Moving to OSW (just offices, not housing people there)

Walk in services: 5 days a week 8am-noon

Property management/degrading: Especially imp. to OSW to conserve architecture Rental inspections: Rental properties need to be certified and inspected every 4 years Q-alert system (Anonymous site to leave code and property issue complaints with city/uses GIS

Works with ARB (Architectural Review Board) to stop non-permitted projects in OSW.

Must have approval from ARB to get a building permit

Focus is "safety, preservation, and health"

Derelict houses

If owner stops complying/will not fix up, goes to court.

30 days to do repairs, must have some movement towards repairs.

EXAMPLE: 522 Day Ave. – boarded up for years; owner does not live in Roanoke Looking at new codes to fix the issue of absentee owners

Police Department is 70 officers short

Not because of funding: Pay is high/signing bonuses

People still saying no to working in the city (going to county and Botetourt)

Only 1 drug enforcement officer

Mental Health is a big deal in the community

Any help from mental health advocates in the community?

To report incidents: Call 911 – they will prioritize. Calls are logged.

Noted missing the (former) monthly community meetings, where they can hear complaints and know what is happening (Staffing issue)

Will provide help rather than jail, when offenders can and are willing.

Change in laws have hampered ability to police the city

Panhandling is covered under the Constitution: Stop paying, to eventually stop asking

Citizens Police Academy

Reserve Police Officers, Retired officers

5th Street OSW corridor issues & discussion: Property damage, loitering, littering, consumption of alcohol on the Southwest Market property, drunkenness, possible drug use/dealing, profane language, taunting passers-by, fights, defecating and urinating in the alleyway, disruption of other businesses and abutting properties, theft/porch thefts, derelict houses, running stop signs, homelessness/squatting on vacant properties.

ABC input:

- Loitering is against regulation
 - Education is first step (of property owners, managers, customers)
- Can do investigation
- Pull ABC license only real power they have if violations, like public consumption (Southwest Market license does not allow consumption on property)
- o ABC responds after the fact, not first responders
- o Email Austin McClure (austin.mcclure@virginiaabc.com) with details of violations
- Drugs are an issue as well
- Problem: Judges not holding property owners accountable with complying with laws.
- Police try to respond, but are short-staffed and need to prioritize calls.

Franklin St. and Day Ave: in process of replacement after it disappeared (covered by insurance) Franklin and King George (was repaired and is already up)

• Partnership with Tree Stewards and Trees Roanoke

They will provide free trees and planting assistance on public property (curb strips, parks, etc.) If interested in a tree in a curb strip near our property, sign up with Terry McGuire (3 people signed up to explore a tree planting in their curb strips).

Note: If neighbors sponsor a tree, they need to be watered regularly for minimum 3 years

Need Volunteers for a fall clean-up, removing invasives, and November tree planting --Woods Ave

This area floods, people camping there and dumping trash.

Would like to clean up, longer term (and remove invasive growth).

Use: Serves as a natural filter (keeps trash from running into Roanoke River)

NEW BUSINESS/open comments

Highland Park garden beds
 OSW was approached by Shawn Jadrnicek for input on establishing raised vegetable
 garden beds in Highland Park in conjunction with activities at Highland Park Elementary
 School.

"Shawn of VT's extension service (and neighborhood resident!) has a gardening educational program in collaboration with Roanoke City Schools, and he would like to build a series of raised beds in Highland Park to serve the Elementary School, since the confines of the school property do not allow for garden construction on site. With the need for an open area with water access and direct sun close to the school, the most feasible site is adjacent to the fountain near the eastern edge of the Park. Before moving forward we'd like to hear from the

neighborhood, so let us know the preferred method for sharing the schematic and gathering feedback from residents on the proposal."

- Need community permission
- Proposed location right next to fountain site for best sunlight and access to water
- Community would have access during off season
- Using modern techniques
 - No weeding, no watering
 - Low maintenance
 - 5 beds (5' x 40')

- Community support through volunteering?
- Proposed schedule for creating the garden area
 - --Install beds and irrigation system and amend soil (first week August)
 - --Cover beds with light blocking woven poly landscape fabric for 6 weeks during growing season to kill existing vegetation (must be covered by second week in August to kill wiregrass or vegetable planting will need to be postponed until fall 2023)
 - --Remove fabric and plant a cover crop of crimson clover (mid-September)
 - --Mow cover crop and reapply light blocking fabric (last week in January)
 - --Plant vegetables (March-April)
- Request for guest speaker suggestions for future meetings. Possible sources: VT Animal Cancer Research Institute, Historical Society of Western Virginia & Director of the O. Winston Link Museum, talk about the Tetero Indian sites within OSW. No discussion or decisions.
