PRESENTER: Trevor Shannon, Battalion Chief, Roanoke Emergency Management trevor.shannon@roanokeva.gov

Trevor shared:

- Info about safety during local emergencies of all kinds & importance of shelter-in-place & evacuation kits. Resource: <u>ready.gov</u> re: checklists for personal/family 72-hour preparedness kits (put in a 5-gallon bucket)
- How to sign up for Star City Alerts Roanoke's official emergency notification system.
- Status of city planning for urban safety related to derailments/railroad emergencies: how Roanoke is working with the railroad to prevent and prepare for disasters like East Palestine, PA.

Presentation Points:

Roanoke now has a deputy coordinator to allow Trevor to do more outreach to the community. They coordinate with police department. NOTE: People can report location of homeless individuals to him. They will check on the people and provide them with resources. Their department deals with/resolves hazmat issues (full hazmat team can be available from Salem to Roanoke within 10 minutes).

They monitor special events for safety. In Roanoke: 1000 people moving or walking is considered a special event. Events of this size require a permit and a special emergency plan in place.

They address 5 phases of emergency handling—from planning through recovery (including future mitigation). In Roanoke, mitigation has helped lessen Roanoke River flooding.

Top Roanoke hazards: flooding, storms, high winds or other special circumstances (like COVID) They are equipped with boats, dry suits, etc. (major funding through FEMA).

Embracing preparedness starts AT HOME: Be prepared with food, etc. for loss of power for at least 3 days. Other needs: flashlights, batteries, oil lamps, candles, water (1 gallon per person per day).

IMPORTANT: Do not drive through standing water. Swift water rescue is very dangerous (more so than fire).

Encouraged people to sign up for Star City alerts for evacuations, etc.

He provided brochures & emergency lists at the meeting and offered more of anything if OSW needs them for distribution.

- Vote 11/16 at OSW Community Meeting. All OSW property owners and renters eligible to vote. Outreach/membership committee prepares ballot.
- At November Community Meeting, each applicant introduces themselves and their interests related to OSW.

Board and committee participation builds community and benefits our Old Southwest neighborhood. The current board members encourage and invite people to consider contributing to our neighborhood in this way.

2. OSW Neighborhood Safety (Cara Becker)

- --Prior to the meeting, Officer Underwood our OSW Resource Officer noted that he had 3 updates to share, but he did not attend.
- --There was a general call for safety concerns to elevate to Officer Underwood. Questions arose about what constitutes reportable safety issues. Mentioned: homeless encampments, people living in deserted properties, repeated drinking/loitering/littering in specific problem locations. It was call to our attention that people have called and sent email to Officer Underwood, but no response was received. Cara Becker made a note to mention this to Officer Underwood. If people have issues, report them via OSW website form, and the OSW secretary will forward to proper channels and also report them directly to Underwood. Letting OSW Inc. know your concerns, as well as Officer Underwood, helps us to stay on top of local concerns. Cara hopes to get Underwood's cards to distribute.

3. Isabel Thornton from Restoration Housing made a brief presentation about their pending project in Old Southwest.

- --Gave attendees an overview of the non-profit & their mission, mentioned a few examples in the city (currently have 7 properties). Dual mission: historic preservation and affordable housing.
- --Provided an overview of proposed adaptive reuse project: proposed 15 "affordable" senior housing (55+), one-bedroom units at Trinity Church (Mountain Ave SW) in the educational/fellowship wing. The project requires rezoning approval from the city to rezone from institutional to residential. They have a purchase agreement with the church. The building needs capital improvements (building most likely will be left vacant if this project does not move forward).
- --"Affordable" rent formula is 30% 80% of median income. Project is targeted for over 55 with fixed incomes. Restoration Housing hopes to offer secure, stable, reliable, safe housing options @\$803 per month. Plan on having a resident in-house manager.
- --Sale includes parking lot that provides adequate parking for the project. The lot will be combined with the current church property as one deed.
- --Church sanctuary will not be used for apartments. It will become a gathering space (worship space, and other events). 3rd St Coffee House will remain housed in the building. Restoration Housing's mission is to be good community stewards and retain ownership of their properties in perpetuity.

4. **RAM House Updates:** Tony Neuron, RAM House Board Member

Current property on Campbell in OSW is being rehabbed. Moving to Elm Avenue next to the former Trust House properties. RAM House offers therapy and homeless assistance resources, provides family assistance, and provides a space for unhoused people to rest, do laundry, have lunch, etc. during the day. OSW residents were offered discount tickets to RAM House's upcoming fundraiser celebrating their 50th anniversary (at the Jefferson Center).
