6:45-7:30 | PRESENTATION: Proposed Changes to H2 District Architectural Guidelines

PRESENTER: Parviz Moosavi, Historic Preservation Planner, City of Roanoke

- Proposed ARB guideline updates regarding:
 - Windows

- No longer have to be "beyond repair" nothing is ever technically "beyond repair" if enough money is thrown at it. This is not feasible for most community members.
- Parviz will supply a list of acceptable materials that have been approved in the past
- Administrative approval from Parviz will still be needed, and extensive documentation of windows' current state is required.
- List will be on the ARB website soon.
- Roofs
 - Slightly expanded replacement options
- Alternative energy
 - Solar panels shouldn't be seen from the street
 - Side or rear of building often okay and subject to administrative approval by Parviz
 - Front face of house is still very unlikely to be approved
 - Solar shingles have been approved

Other Notes

- Bill Mason (ARB member):
 - The board researched 4 other cities with similar guidelines and discussed with multiple consultants in a process extending over 3-4 years
 - Richmond
 - Lynchburg
 - Staunton
 - Wvtheville
 - Overview of how guidelines work discussed 200 applications a year to review
 - Current guidelines leave a lot of gray. Not contextual people have to prove they need a new roof, shingles, window, door, etc.

Parviz:

- Reviewed current process, H-2 areas, passed out the latest revisions to the guidelines - which are not approved yet. Revised H-2 guidelines to be approved/released by Summer
- Targeting growth through preservation
- The aim is to keep historic look and character of old houses, but as part of the process, they're getting input from the historic communities around the city
- 1970s saw a lot of historic buildings being torn down
- In 1979 city adopted ARB + historic districts
- Old SW is in H-2 Historic District
- The ARB reviews changes and demolitions and makes sure people comply and file the proper paperwork (Certificate of Appropriateness - COA).
- Working on getting Norwich added to the H2 district
- Historic renovations provide opportunities for owner tax credits
- ARB is interested in holding workshops focused on historic renovation, restoration, and maintenance

- In 2023:
 - 119 applications reviewed and administratively approved by Parviz
 - o 6 denied
 - 2 appealed to City Council
 - 1 appeal reversed, 1 denied
- ARB's changes are fitting into City Plan 2040
 - Responding to new materials and technologies
 - Improving process clarity
- Public Comments:
 - New RAM House property must meet the ARB guidelines just like any other property
 - This is a large project and they will have another design meeting
 - Extensive discussion occurred around a perceived double standard in enforcement of ARB guidelines. There are roofs falling down, gutters off the sides of houses, windows boarded up.
 - A member observed that the city has very poor code guidelines and seemingly no teeth to enforce them, which lets negligent owners get away with all sorts of stuff they shouldn't
 - Concerns were raised about the ARB and code enforcement not collaborating effectively to get issues resolved.
 - o Derelict housing doesn't seem to be reclaimed/sold by the city often enough
 - The prices for new work is really high and many owners can't afford basic replacements - how can ARB be flexible/contextual?
 - The current process is hard to follow when trying to do the right thing and work with the ARB
 - Code enforcement is MIA and not working with owners and the ARB to get money/fines from building owners
 - Need support from Richmond for increased code enforcement

- City of Roanoke proposed zoning amendments update

- Council voted 5-2 in favor of zoning changes that end exclusive single-family zoning throughout the city
- Changes have the potential to significantly impact OSW
- Efforts ongoing to work with the city to formally integrate code enforcement and stronger protections against negligent owners - contact Jan Keister:
 - In general, the city wants other neighborhoods to emulate OSW
 - However, the changes open up opportunities for more slumlords
 - More affordable housing is good, but we don't want to go back to the sort of unsustainable density we've seen in the past in OSW
 - The changes likely won't resolve the city's issues
 - Jan to meet with representatives from the city in April
- Some are considering taking legal action against the city
- Jan has lots of information and could use some more support from interested parties
- The city has started a derelict property registry (sorely needed) but it's in its infancy
