- Why it's important. (OSW pride, rentals, preservation)
- What to bring: gloves, shovels, rakes, clippers/trimmers
- We could help edging between bricks/lawn Volunteer? Laurie offered for Stephen to look at her edger to see if it's working.

#### 2. Roanoke City Code Compliance:

Solutions to Address Non-Performing Properties for more housing, historic preservation & neighborhood improvement

#### PRESENTERs:

#### **Discussion Order**

 Intro of OSW Interests: Turn around "derelict" houses to improve OSW safety, appearance, value, historic preservation, plus increase housing inventory, city revenues (Simon Wolf, President)

-Captured existing code issues from the floor (Mary Anne Mather, Secretary)

- Specific Issue at Air BnB at 711 4<sup>th</sup> Street. No longer owner occupied. Not being maintained. Often not mowed. Continuously has short-stay rentals – not allowed by code.
- Abandoned, unlicensed vehicles (code oversees inoperable vehicles on private property, police deal with vehicles on public property/streets).
- Need for more frequent rental inspections

# **–Short presentation of how code compliance works** (Jeffrey White) General Info:

- Wants us to know that our code department is responsive. Constituents have their attention. They commit to get answers to neighborhood questions.
- 11 inspectors (11 zones in city). Inspectors work the neighborhoods and also attend neighborhood events on weekends and weekends, as needed.

- --Address "private" property.
- -- Use VA Maintenance code Part 3 as their enforcement guideline.
- --Oversee rental inspection program (inspections every 4 years). 74.5% are considered rental in OSW.
- --50% of code complaints come from canvassing and 50% from call-in complaints.
- --After owners are taken to court, that exhausts what code can do. x
- --Code/property court: 1st Thursday of the month (28-30 per month).

#### Questions from Floor:

- Question: is there higher incentives for frequent offenders? Answer: Only if same problem at same property. Habitual offenders for mowing – have 7 days to comply before city sends a contractor out to mow.
- Question: Sounds like judge's penalties are completely arbitrary. Can penalties be made public? It was noted form the floor that often the judges levy very lenient fines, which exacerbates code problems/non-compliance. There is "no teeth" in the code.

  Answer: (none recorded)
- Question: What is the percentage of repeat code offenders?

  Answer: Generally low. Repeat offenders are a small number of the same people. (It was noted from the floor that these small number of offenders are habitual, problematic, and have little incentive to comply. This needs a resolution.)

- Betsy demonstrated how to find code reports, owners, violations, ARB/COAs, etc. for any property.
- Neighbors can write letters and give to code to take with them to court.
- -Discussion & Questions (open)
- Neighborhood wants to see a change in the City's allowing non-performing houses to exist inperpetuity.
- City is looking at language to create a vacant houses registry. Proposed for increase in fees for vacant house.
- Jeffrey White will research a problem property on Mountain Ave. owned by Dearing (a habitual offender).
- Judges are appointed by general assembly Question: Do we need to approach our representatives to change of influence the judges to do a better/more-effective job? Also approach our representative to address the vacant house registry.
